Based on ADF refusal to communicate, it might appear that (1) ADF either has sided with the cause of Sweden's anti-Biblical and anti-Christian national agenda and therefore do not want to lend legal advice or support for this case, or, that (2) ADF do not know any defence lawyer in Sweden who also is a Christian. From the ADF conduct towards me so far, it would speculatively seem that ADF might have chosen to prioritize loyalty with churchianity's pastoral persecution against Torsten at the cost of Biblical truth. Essentially all pastors of churches have evidentially demonstrated that, in reality, truth is irrelevant. We also know, evidentially, that most pastors of churches seek to harm the Christians who speak uncomfortable truth. Adina,

Your response of confirmation is proper and good, although a confirmation of receipt should ideally be confirmed within no longer than 24-hrs.

Your response with a diffuse answer that "your request is being processed" without a time frame of producing a proper answer, however, is not quite so good.

**When will ADF answer if ADF can advise of any Christian defence lawyer in Sweden?**

People (and lawyers) in Sweden who might attribute themselves with the title "Christian" may actually be hostile towards Bible-affirming Christianity and may support the practice of homosexuality, and thus would be inappropriate as a defence lawyer. That is why I need a recommended lawyer. If you cannot recommend a defence lawyer in Sweden, then I will need to ask an entirely different entity if they might know if there exists a recommendable defence lawyer in Sweden.

Alliance Defending Freedom (ADF).

Hi again Adina Portaru,

As requested by the Swedish Police, I presented myself today (April 3, 2017) to the Swedish Police at their Police Headquarters in Stockholm, for questioning. The Police stated in that brief meeting that I was suspected of hate crime. The Police then asked me if I wanted to answer the Police questions directly, or if I wanted a defence lawyer present during the questioning. I answered that I preferred to have a defence lawyer present during the questioning. The Police then said that they could provide a defence lawyer. I then asked the Police if I may choose a defence lawyer myself, and the Police affirmed that I may choose the lawyer myself if I know of a particular lawyer. I said to the Police that I would like to inquire with a legal network of Christians if that network can advise of a Christian lawyer in Sweden, and if the next occasion for questioning by the Police could be on May 27, 2017. The Police affirmed that I may seek my own defence lawyer and that May 27 will be OK, and that the Police wanted me to maintain email updates to the Police regarding my progress of identifying a specific defence lawyer towards that date for questioning on May 27.

**Would ADF please advise me of a Christian defence lawyer in Sweden?**

Additional information:

At the front entrance to the Police Headquarters in Stockholm, Sweden (Kungsholmsgatan 43) is a rainbow symbol. The modern (hijacked) rainbow symbol is a contemporarily symbolic for LGBT-support and pride. There were no other symbols on the Swedish Police Headquarters in Stockholm. Question: **Can a Federal Police Force that publicly sides with LGBT-support be perceived as objective and credible in its investigations?**

However, given the running period, you should urgently reply to the Swedish Chancellor of Justice (JK) , and ask for anstånd (postponement) for three weeks with his reply. The legal deadline to do so is today.

We advise you to obtain legal advice in Sweden in order to seek postponement and to let us know how the legal proceedings are developing. We will further review your case.

Dear Madame or Sir,

On Monday Sept. 12, 2016, Sweden declared intent to pursue criminal investigation against Torsten for hate speech. Swedish Police interfered and prohibited Torsten from publicly reading verses from the Bible. The speech titled 'The essential Biblical perspective on human homosexuality' is entirely Bible based. The Swedish Police stopped Torsten's modestly presented tone of Biblical speech. The police asserted that Sweden equates public readings from the Bible with public readings from Adolph Hitler's 'Mein Kampf'. To the Swedish Police (and possibly also to the Swedish prosecutors), the Judeo-Christian Bible, which is God's Holy Word, is equally as hateful as the words of Adolph Hitler. In Sweden, God and Adolph Hitler are equally hateful. An audio recording of Torsten's written speech and of the Swedish Police interference exists.

Swedish Police statements to Torsten on Sept. 12, 2016:

- "Do you know who Hitler was? You know he has written a book; Mein Kampf. But if anyone would stand and read it, it doesn't matter if it is in a book. It is still hate speech. **It does not matter if it is in the Bible.**"
- "When you speak about homosexuality as something patronizing or wrong, then we have a problem."
- "You are suspected of crimes that you are required to not do."
- "I have seen that it is hate speech."
- "What is going to happen is that a police report will be prepared and you will be called for questioning."

On March 1, 2017, the Swedish Chancellor of Justice (<http://jk.se/other-languages/english/>) confirmed (attached PDF document: Justitiekanslern 7374-16.pdf) that the Swedish Police are still preoccupied with a preliminary investigation against Torsten for hate-speech crime.

The documentations are in Swedish language.

There are several inaccuracies and untruths in the Swedish Police reports provided by the Swedish Police to the Swedish Chancellor of Justice.

I would like to seek ADF legal assistance for two processes:

**(1)** Legal assistance in correcting the false Police reports about Torsten to the Chancellor of Justice.

**(2)** Legal assistance for legal defence, if the Swedish Police ongoing preliminary investigation against Torsten amounts to prosecution against Torsten.

For process (1), the opportunity to correct the false Police reports about Torsten to the Chancellor of Justice is set by the Chancellor of Justice to March 21, 2017.

Is freedom of speech in defending Biblical Christian ethics something which ADF is supportive towards, and ADF finds to be important?
