CBSA.

The information in your letter evades truth and responsibility.

Firstly, you distort truth when you claim "*officers believed you would be attempting to stay in Canada without a valid visa*". All the CBSA officers, including the senior CBSA officers, were fully aware that I had no intention to remain in Canada beyond the maximum permitted time. Without I saying so upon my arrival, the CBSA officers asked me if I had the intention to remain in Canada for six months, to leave Canada for one month, and to return to Canada for an additional six months later. I affirmed that this was my planned intention. The same first CBSA officer then replied to me that he was intending to provide the documents necessary for me so that I could remain in Canada without having to return to Sweden every six months. I then responded to the CBSA officer's proposal that it was a generous offer, but that I still have to leave Canada after six months, because I have appointments every six months for an MRI/CT exam (former testicular cancer) in Sweden every six months. Contrary to your CBSA untruthful claim "*officers believed you would be attempting to stay in Canada without a valid visa*", all CBSA officers knew that I had denied the CBSA offer to remain in Canada longer than six months, because I have a necessary medical exam in November 2011, and that my return ticket is in November 2011. In regards to this CBSA accusation, CBSA confirms, through you, that CBSA is an organisation that endorses its lies. CBSA in this regard proves that it has no integrity and no truth. Shame on you for deliberately lying!

Additionally, the Canadian admission stamp in my passport was already valid until September 2011.

In regards to the demonstrated emotional rage of one CBSA officer and the expressed profanity of another CBSA officer, you refer to reinforcement of civility in the CBSA agency training program. I specifically identified the ID of the CBSA officer who used profane language at me. Evidently, your CBSA training program on civility is not effective for the CBSA officers. The CBSA officers that conduct themselves as emotionally unstable or as spiritually invoked (demonised), or that use profane language, should be accountable before a court of law, should be professionally penalised, or have their employment contracts as CBSA officers terminated.

Therefore:

- 1) I request that the responsible CBSA officers be charged for their misconduct.
- 2) I request that CBSA apologise to its victim for these CBSA misconducts.
- 3) I request that CBSA acknowledge the (recorded) truth. I request that CBSA, thereby, reverses the CBSA decision to extradite me from Canada, which evidently has no factual foundation whatsoever. All facts indicate and prove the opposite; that in spite a CBSA offer to remain beyond the six months, Torsten Nenzen specifically said that he would still be returning to Sweden in November due to a booked flight in November, and due to a necessary medical exam in Sweden in November.

Through your letter, you confirm that CBSA is an organisation of shameful liars.
